



**NOTICE OF DECISION FOR OFFICIAL PLAN AMENDMENT AND
ZONING BY-LAW AMENDMENT
BY-LAW NO. 39-2018 AND BY-LAW NO. 40-2018**
Planning Act, R.S.O. 1990, c.P.13, s. 34, s. 17

NOTICE is hereby given, that the Council of The Corporation of the Municipality of Red Lake passed By-Law No. 39-2018 and By-Law No. 40-2018 at their Regular Meeting held Tuesday, May 22nd, 2018, thereby giving approval to an Official Plan Amendment and Zoning By-Law Amendment.

LOCATION OF PROPERTY: Various lands in the Municipality of Red Lake

PURPOSE AND EFFECT OF BY-LAW: The amendments entail: housekeeping changes to revise errors and improve the clarity of the text and schedules; changes to the zoning of specific properties to revise errors and re-evaluate holding zones; and changes to the Official Plan designation of specific properties to allow existing zones to comply with their designations.

THE LAST DATE FOR FILING A NOTICE OF APPEAL is Wednesday, June 13th, 2018.

OTHER PLANNING APPLICATIONS RELEVANT TO THE SUBJECT LOCATION: None.

Notices of appeal:

- i. must be filed with Christine Goulet, Clerk of The Corporation of the Municipality of Red Lake
- ii. must set out the reasons for the appeal, and
- iii. must be accompanied by the fee required by the Local Planning Appeal Tribunal of \$300.00

Only individuals, corporations and public bodies may appeal a by-law to the Local Planning Appeal Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of appeal unless, before the by-law is passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Local Planning Appeal Tribunal, there are reasonable grounds to add the person or public body as a party.
